INTERNAL AFFAIRS INVESTIGATIVE SECTION (IAIS)

THE IAIS OF THE HIGH BRIDGE POLICE DEPARTMENT IS CHARGED WITH THE RESPONSIBILITY TO CONDUCT ALL INTERNAL AFFAIRS INVESTIGATIONS WITHIN THE HIGH BRIDGE BOROUGH POLICE DEPARTMENT. THESE INVESTIGATIONS MIGHT INCLUDE COMPLAINTS AGAINST PATROL OFFICERS, DETECTIVES, OR OTHER SWORN AND NON SWORN PERSONNEL OF THE POLICE DEPARTMENT. INVESTIGATIONS MAY BE ADMINISTRATIVE OR CRIMINAL IN NATURE.

THE IAIS DIVISION ALSO WORKS HAND IN HAND WITH THE COUNTY PROSECUTOR'S OFFICE IAIS UNIT IN CASES WHERE SERIOUS ALLEGATIONS OF IMPROPER CONDUCT ARE ALLEGED AGAINST OFFICERS OR OTHER SWORN PERSONNEL.

THE IAIS IS COMPRISED OF ONE SERGEANT. IN ADDITION TO INTERNAL AFFAIRS MATTERS, THE SERGEANT IS ALSO TASKED WITH CONDUCTING INVESTIGATIONS INVOLVING DISCRIMINATION, SEXUAL HARASSMENT, AND HOSTILE WORK ENVIRONMENTS IN THE WORKPLACE.

ANY PERSON, WHO FEELS HE/SHE WAS THE SUBJECT OF IMPROPER CONDUCT OR ACTION WITHIN THE BOROUGH OF HIGH BRIDGE, SHOULD CONTACT THE INTERNAL AFFAIRS OFFICE OF THE HIGH BRIDGE BOROUGH POLICE DEPARTMENT. IF THE ALLEGED CONDUCT HAPPENED ELSEWHERE THE COMPLAINANT SHOULD CONTACT THE LOCAL OR STATE AGENCY WHERE THE CONDUCT IS ALLEGED TO HAVE OCCURRED.
