MAYOR AND BOROUGH COUNCIL

Meeting Date: June 27, 2013

CALL TO ORDER: The meeting of the Mayor and Council of the Borough of High Bridge came to order with Mayor Desire presiding, at 7:30 PM on the above date. "Pursuant to the Open Public Meetings Act, notice of 2013 meeting dates was published in the Hunterdon County Democrat on January 10, 2013 and posted on the bulletin board in Borough Hall. The meeting was held in the Fire House, 7 Maryland Ave., High Bridge, NJ. Action may be taken."

Mayor Desire led those present in the salute to the Flag.

Attorney Barry Goodman, Municipal Deputy Clerk MaryBeth Griffith and four members of the general public were also present.

VISITORS: Darlene Green, Borough Planner, explained the "Exemption Ordinance" giving an overview of the Ordinance and its exemptions. Mrs. Green stated "Highlands has asked Council to review their fee set at \$350". Discussion took place in regards to adjusting the fee. Barry Goodman recommended a flat fee rather than basing it on an hourly rate. Councilman Flynn suggested that since there is no range set nor other towns (municipalities) for comparison set the rate at \$300 then revisit it. Council amends the Ordinance to change the rate schedule from \$350 to \$300.

Councilwoman Miller motioned to dispense with the reading of the Regular and Executive Session Meeting Minutes of June 13, 2013. Councilman Stemple seconded. Roll Call Vote: Flynn, aye; Hughes abstained; Miller, aye; Scarcia, aye; Stemple, aye. Motion Carried: 4 ayes and 1 abstention.

APPROVAL OR CORRECTION OF PRIOR MEETING MINUTES:

Councilman Stemple motioned to approve the Regular and Executive Session Meeting Minutes of June 13, 2013. Councilwoman Miller seconded. Roll Call Vote: Flynn, aye; Hughes abstained; Miller, aye; Scarcia, aye; Stemple, aye. Motion Carried: 4 ayes and 1 abstention.

PUBLIC COMMENTS: It is the policy of the Borough Council that all public comments on an issue shall be limited to five (5) minutes per person and no person may make more than one (1) comment per subject. Comments may be made on any subject pertaining to Borough issues. Comments pertaining to Public Hearings should be saved for that portion of the agenda. No debating between residents. Comments should be addressed to Mayor and Council.

Dr. Coughlin asked who was paying for the trailer at the golf course. Councilman Stemple confirmed that the title of the trailer will be titled to the Borough and listed on the Borough's books. In reference to Resolution #131-2013, Dr. Coughlin explained that severance is usually given when someone is dismissed from a position. Administrator, Doug Walker left on his own accord and therefore wonders why additional compensation is being extended to a salaried employee and why spending tax payer's money is being spent on this. In the past, there have been other individuals who have left and none have ever received severance pay. Councilman Flynn clarified that the reasons for this decision are listed in Resolution #131-2013. Ron Huttemann expressed his disapproval in giving severance pay to former Administrator, Doug Walker.

The Borough maintained a credit rating of AA-. 2012 Auditor report contains no recommendations from the Auditors. A meeting is scheduled with Bonnie the week of July 15th. The High Bridge Golf Course was rated 34th top public golf course in the state by New Jersey Monthly. A meeting is set up with Ryan Phelps, Regional Director of Billy Casper Golf for July 8th. Plan to do a drive thru at the golf course with Jay within the next couple weeks.

e. **RESOLUTION #134-2013:** Approve Initiation of Face Book page by EDC.

Discussion: Councilman Stemple questioned if the administrator of the site needs to be a Borough employee or a Council person being that the site is representing the Borough. Concerns that someone not affiliated with the Borough would be making decisions and posts could potentially reflect the Borough negatively. Councilwoman Miller explained that the website is maintained by a paid professional and that no public posts can be accepted. After much discussion, Council agreed that all Face book updates will be required to go through a Council liaison to the EDC to assure that all posts are appropriate. The wording of the resolution will be revised.

Motion to amend Resolution #134 stating that all posts must be approved through a Council liaison to the EDC before content is posted.

Councilman Flynn stated the Borough was awarded a \$250,000 transportation enhancement grant for Main Street Streetscape Phase 2. He explained someone is needed to attend these sessions in the absence of Administrator, Walker. The Borough Engineer will be given \$600 for the cost of his time dividing it 50/50 between us and his company with the cost not to exceed \$600.00.

Councilwoman Hughes motioned to adopt Resolution #138 as amended. Councilwoman Miller seconded. Roll Call Vote: Flynn, aye; Hughes, aye; Miller, aye; Scarcia, aye; Stemple, aye. Motion Carried: 5 ayes.

g. RESOLUTION#136-2013: Award of contract for website maintenance.

Councilwoman Miller clarified Hunterdon Business Services will be billed hourly therefore the cost could be less than \$450/month. Councilman Flynn stated the importance of being aware of all costs.

It will most likely be held some time this Fall. Sally Ward commented how awesome the Soap Box Derby was and the amazing job performed by the DJ. Adrienne Shipps thanked Council for approving Face Book page and said a draft will be available shortly for review. She assured Council the policy was written with the proper amount of restrictions on postings. As advances in technology arise, EDC will accommodate necessary changes. Dr. Coughlin asked where the money would be coming from to pay Doug Walker's severance. Councilman Flynn stated it is budgeted in payroll/salary line.
