**RESOLUTION #13-2014
BOROUGH OF HIGH BRIDGE
COUNTY OF HUNTERDON, STATE OF NEW JERSEY**

ANNUAL MEETING SCHEDULE

WHEREAS, the Open Public Meetings Act (Ch. 231, P.L. 1975) provides for the giving of annual notice by public bodies of the time, date and location of the regular meetings of such public body to be held during the succeeding year, and

WHEREAS, the Open Public Meetings Act (Ch. 231, P.L. 1975), hereinafter referred to as the Act, authorizes a public body to make certain other determinations and take certain other actions in conformance therewith.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of High Bridge, County of Hunterdon and State of New Jersey as follows:

1. Regular meetings of this council shall be held during the 2014 calendar year at 7:30 pm at the High Bridge Fire House, 7 Maryland Ave., High Bridge, New Jersey, on the following dates:
 - a. The second and fourth Thursdays of each and every month **except for** January, July, August, November and December.
 - b. Those meetings will be held on January 2nd (Reorganization Meeting) and January 23rd, July 17th, August 14th, November 20th and December 18th.
 - c. January 23rd, February 13th and 27th, March 13th and 27th, April 10th and 24th, May 8th and 22nd, June 12th and 26th, July 17th, August 14th, September 11th and 25th, October 9th and 23rd, November 20th and December 18th.
2. Copies of this Resolution and any revisions or modifications thereof, certified to be true copies by the Clerk of this municipality, be disseminated and distributed as required by the Act as follows:
 - a. Posted and maintained throughout the 2014 calendar year on the bulletin board at the High Bridge Borough Hall.
 - b. Mailed or hand delivered to the newspapers designated as the official newspapers of the Borough.
 - c. Filed with the Clerk of this Municipality.
 - d. Mailed to such other persons as may be entitled thereto under the terms of the Act and this Resolution.
3. Pursuant to Section 14 of the Act, the Clerk of the Municipality is hereby authorized and directed to mail such notice as may be required and authorized under the Act to any person requesting the same providing that person has first complied with the following term and condition:
 - a. Any and all requests for notice under the Act shall be made in writing as an OPRA request.
