**ENDORSEMENT OF THE MUNICIPAL RECYCLING TONNAGE GRANT APPLICATION AND
DISIGNATION OF RECYCLING COORDINATOR/ASSISTANT COORDINATOR FOR 2015**

WHEREAS, the Mandatory Source Separation and Recycling Act, P.L. 1987, c. 102, has established a recycling fund from which tonnage grants may be made to municipalities in order to encourage local source separation and recycling programs; and

WHEREAS, it is the intent and spirit of the Mandatory Source Separation and Recycling Act to use the tonnage grants to develop new municipal recycling programs and to continue and expand existing programs; and

WHEREAS, the New Jersey Department of Environmental Protection is promulgating recycling regulations to implement the Mandatory Source Separation and Recycling Act; and

WHEREAS, the recycling regulations impose on municipalities certain requirements as a condition for applying for tonnage grants, including but not limited to, making and keeping accurate, verifiable records of materials collected and claimed by the municipality; and

WHEREAS, a resolution authorizing this municipality to apply for such tonnage grants will memorialize the commitment of this municipality to recycling and indicate the assent of the Borough Council of the Borough of High Bridge to the efforts undertaken by the municipality and the requirements contained in the Recycling Act and recycling regulations; and

WHEREAS, JoAnn Fascenelli of Lebanon Township shall be designated the 2015 Recycling Coordinator for an annual rate of \$500.00 with Jennifer Harrington assisting in the preparation and filing of the completed reports for the Borough of High Bridge for an annual rate of \$2,000.00.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of High Bridge, in the County of Hunterdon and State of New Jersey, that the Borough of High Bridge hereby endorses the submission of a Municipal Recycling Tonnage Grant Application to the New Jersey Department of Environmental Protection, Office of Recycling and designates JoAnn Fascenelli, 2015 Recycling Coordinator, and Jennifer Harrington, Assistant Recycling Coordinator for the Borough of High Bridge, 71 Main Street, High Bridge, New Jersey, 08829, to ensure that the said Application is properly filed.
